## Charles D. 'Charlie' Smith

City Councilman Charles D. "Charlie" Smith, 71, Warsaw, passed away in a single-engine plane crash Oct. 2, 2015, on the South Carolina side of Lake Hartwell in Oconee County.

He was killed in a plane crash en route to the Notre Dame vs. Clemson football game Friday afternoon as he was an avid Notre Dame fan.



He was born Aug. 2, 1944, in LaPorte, to Harry DeVon Smith and Edna LaVerne Maurer Smith. On Dec. 3, 1999, in Warsaw, he married Ann Slone Vanderlinden, who survives in Warsaw.

He was a 1962 graduate of Walkerton High School. He then received his bachelor's of science in 1967 from Manchester College, North Manchester and his master's degree in 1974 from St. Francis College of Fort Wayne.

He was known to many simply as "Coach," having coached many students over his 16-year teaching career at North Manchester, Triton and then Tippecanoe Valley.
